Overview

The annual subscription for UK residents is £15 to the following 31st May. Those subscribing in April are credited with membership from May onwards.

We invite those joining between December and March, if they wish, to pay £20, which will give them membership until the May after next.

If you live outside the UK, you may wish to pay your membership in US Dollars or in Euros.

For those who wish to pay in US dollars, the rate is \$30 for a £15 subscription and \$40 for a £20 subscription.

For those who wish to pay in Euros, the rate is €25 for a £15 subscription and €35 for a £20 subscription. We regret that we cannot accept Euro cheques; please pay by one of the electronic methods below.

Also, you can purchase copies of the Society constitution for an additional £2.50, \$5 or 5 Euros.

You can pay for membership and copies of the Society constitution in a number of ways, including PayPal; please see below.

For your own security we cannot recommend that you mail cash in any currency.
